Mr. Munawar Ali Abbasi, Asst. A.G., along with DSP Asadullah Bhatti, SDPO Mirokhan/Chairman JIT and Insp. Shafqat Kanasiro, SHO PS Mirokhan.

None present for the petitioner. Per annexure-A, page-13 of the Court file, one Muhammad Hassan Brohi, husband of alleged detainee Mst. Nazeeran Khatoon had filed Cr. Misc. Appln. No.872/2024 before the Court of Sessions, Kamber-Shahdadt and later it was assigned to learned 1st Additional Sessions Judge, Shahdadt re-Muhammad Hassan v. SHO Mirokhan & others. Learned Additional Sessions Judge after due notice and calling reports from the concerned, dismissed the same on the ground that the petitioner himself was not aware of the whereabouts of the alleged detainee vide his order dated 10.6.2024. Later, the present petitioner also filed C. P. No.S-212/2024 before this Court, which too was disposed of as not pressed vide order dated 27.6.2024; hence, it is second petition for the same cause of action.

DSP Asadullah Bhatti, SDPO Mirokhan/Chairman JIT, assisted by Inspector Shafquat Kanasiro, SHO PS Mirokhan, submits that after registration of FIR being Crime No.79/2024, u/s 365-B, PPC with PS Mirokhan, when they obtained CDR in respect of Cell No.03093511581 owned by alleged detainee, they learnt that it was the registered number of petitioner and when she was approached and asked that her number is being used by alleged detainee, the petitioner herself has changed her whereabouts and it is not known where she has gone, therefore, they have no clue with regard to the availability of the alleged detainee; hence, seeks more time. As an indulgence and strictly as a last chance, office to issue direct to the petitioner and intimation notice to her Counsel, for 17.03.2025.
