Without touching merits or demerits of the case, applicant Bakhar Phull alias Bakhar son of Allah Warayo Phull is admitted to protective bail for eight (08) days from today in Crime No.41/1992 of Police Station Taluka, Larkana, registered under Sections 324, 353, 34, PPC & 13-DAO, subject to his furnishing solvent surety in the sum of Rs.50,000/- (Rupees fifty thousand only) and P.R bond in the like amount to the satisfaction of Additional Registrar of this Court, thereby enabling the applicant to surrender before the Court concerned i.e. Sessions Judge, Larkana, for appropriate relief. Meanwhile, operation of NBWs, if any, issued by the trial Court against the applicant shall also remain suspended for said 08 days.

This order shall cease to operate on expiry of 08 days from today i.e. on 28.02.2019 or such earlier date when the applicant surrenders before the Court concerned, whichever is earlier.
