ORDER

Muhammad Osman Ali Hadi, J. (1) Urgency granted. (2) Deferred (3) Learned counsel undertakes to place on record certified copies, true translations etc. during the course of the week; application disposed of in terms herein. (4) The Applicant acting through an authorized person seeks transitory / protective bail as he is presently in Dubai and arriving at Karachi via flight that lands on 01.01.2026, in respect of F.I.R. ASO-749/2025-HQ, registered on 12.12.2025 before P.S. Collectorate of Customs, Enforcement, Customs House, Karachi, pertaining to offence/s under Section/s 16, 17, 32(1), & (2), 32A, 79(1), 178 and 187 of the Customs Act, 1969 punishable under clauses (1), (9), (14), (14A), (44) and (45) of Section 156 read with Sr. No. 7, Appendix-B, Part-II of the Import Policy Order, 2022, Imports and Exports (Control) Act, 1950, Sales Tax Act, 1990, Income Tax Ordinance, 2001 and allied laws and rules made thereunder.

2. Learned counsel submits that the applicant has been erroneously nominated in the aforementioned case and is intent upon surrendering to the Trial Court. However, in order to be enabled in such regard, the Applicant seeks to be admitted to protective bail.

3. In view of the foregoing, and without adverting to the merits of the case¹, the applicant is admitted to transitory / protective bail for a period of ten days from the date hereof till end of Court hours on 09.01.2026 or upon surrender of the applicant before the Trial Court, whichever is earlier, subject to furnishing solvent surety in the sum of Rs.25,000/- (Rupees Twenty Five Thousand Only) and a personal recognizance bond, in the like amount, to the satisfaction of the Nazir of this Court.

4. This Criminal Bail Application stands disposed of accordingly.
