The instant Suit and Suit No.1259 of 2011, Suit No.1450/2011  
Suit No.1123 of 2012 are between the same Parties. Out of the said four  
Suits, three Suits have been filed by Mrs. Samia Aamir in which she is  
the Plaintiff and in the 4<sup>th</sup> Suit of the Defendant is namely Imra Waquar  
Imran. The controversy in all these four Suits arising after the death of  
the parents of the Plaintiff and the Defendants in these Suits. The  
Plaintiff claims that certain moveable and immoveable properties left by  
the Deceased father and the mother, which were supposed to be the  
Estate of the Deceased parents have allegedly been transferred and/or  
removed by other legal heirs of the Deceased parents has deprived hereof  
her inheritance. However, on the other hand the Defendants' stand is  
that the title documents, produced by the Plaintiff herself and stated in  
the Memo of Plaint, shows that the said properties already belong to  
them and the said properties were not in the name of Deceased parents.  
Be that as it may, the issue of inheritance has been raised by the Plaintiff  
in the above three Suits and the fourth Suit by one of the Defendants is

in fact defence of the said Defendant as he claims ownership in his own right. In all the four Suits conveniently common Issues can be framed to settle the dispute that whatever the Suit Properties were left by the Deceased parents of the Parties and the same are owned by contesting Defendants in their own right. Therefore, the Plaintiff and the Defendants are directed to examine all the four Suits and try to submit consolidated Issues with respect to each and every moveable and immoveable properties involved in these four Suits to claim their rights in respect of such properties. For the purposes of possible consolidated Issues, this matter is adjourned to 12.03.2014.

Office is directed to fix all the four Suits mentioned above in Court on the same date. Suit No.1450/2011 and Suit No.1123 of 2012 are not fixed today. They may also be listed on the next date of hearing.

It is clarified that all the four Suits are ordered to be placed together only in view of the possible consolidation of the cases. In case the Parties come to the conclusion that these cases are not going to be consolidated then, the same should be fixed separately on the next date.
