Mr. Raja Hassan Nawaz, Advocate is appearing in this case since 19.01.2012 under a Vakalatnama which was presented on the said date. Vakalatnama shows that he is appearing on behalf of Muhammad Umer Farooq son of Ch. Muhammad Farooq, through Attorney. Unfortunately the name of the attorney is not mentioned in the Vakalatnama nor any Power of Attorney has been filed till date. He claims that no document is available with him. It is indeed unfortunate for the High Court Lawyer that after more than two years filing of Vakalatnama he is not aware of the name of his client and his client's name is not mentioned on the Vakalatnama. Therefore, he cannot address the Court. When he was asked to file Power of Attorney he states that attorney is out of Pakistan. It is again strange that he has filed his Vakalatnama, nor name of attorney neither CNIC number nor the address of his client anywhere mentioned. I am afraid it is totally negation of the Bar Council's rules and therefore, he is discharged unless he is properly briefed by an specific person for representing in the Court.

The order sheet dated 28.11.2013 shows that nobody was appearing for the petitioner. On 22.12.2011 directions were given to the petitioner to file amended plaint within ten days and thereafter on 30.8.2012 one months time was allowed to file the amended title. Then the last 2/3 years nobody is appearing on behalf of the petitioner therefore the order for amendment of the title has not been complied with. In view of these facts, the petition is dismissed for non-prosecution.
