



**ORDER**

**AMIR HANI MUSLIM, J.-** By consent the following  
order is passed:

1) The petitioner shall be entitled to have the minors with  
him as under:

(a) On every alternate first and third Saturday of the  
month and on every second and fourth Sunday  
from 10.00 a.m. to 5.00 p.m;

(b) On both Eids from Eid Namaz time in the  
morning till 4.00 p.m. in the afternoon;

(c) On the 9<sup>th</sup> and 10<sup>th</sup> of Moharram from 9.00 a.m.  
till 7.00 p.m;

(d) On their birthdays, i.e. 23<sup>rd</sup> October, after school  
hours till 7.00 p.m;

In respect of the above the petitioner shall pick the children from the residence of the respondent himself or through his family member and shall drop them in the same way

- 2) Both parents, the petitioner and the respondent, may take the minors on vacation for one month during school holidays both within the country or abroad with prior one month's notice to the other side. If the petitioner takes the minors abroad the respondent shall provide the passports of the minors to the petitioner in advance and on return of the minors the passports shall be returned to the respondent. In case NOC is required, the same shall also be given by either party. The party who is taking the minors within the country or abroad shall provide complete details of their tour, residence and copies of the travelling documents.
- 3) If during vacations either party is not taking the minors within the country or abroad, the petitioner would be entitled to have the custody of the minors for five days of the winter vacation and fifteen days of each month of the summer vacations.
- 4) In case of any emergency the respondent will be entitled to take the minors out of Karachi to see her mother or brother.
- 5) The petitioner shall pay the actual school fee of the minors from this month (November 2014) onwards. Presently the school fee is Rs.21,000/- (twenty one thousand rupees) per month in respect of each minor,

i.e. total of Rs.42,000/- (forty-two thousand rupees) per month. Since the respondent has paid the advance school fee till July 2015, the petitioner shall remit an amount of Rs.378,000/- (three hundred seventy-eight hundred rupees) within 15 (fifteen) days from today in the Account of the respondent, i.e. A/C No. 0144302010036409 of Muslim Commercial Bank, Zamzama, D.H.A. Karachi Branch Code 1443 titled "Sana Saeed Sattar" and in future the petitioner shall directly pay the school fee of the minors to the concerned schools in consultation with the Respondent.

- 6) The petitioner shall pay the actual medical bills of the minors on receiving the copies of the same from the respondent by crediting the amount into the aforesaid account of the respondent, within one week from the receipt of the same.
- 7) That the petitioner being father would be at liberty to pay maintenance of the minors in addition to the present arrangement.
- 8) The parties would be at liberty to vary the aforesaid terms by mutual consent.

With the consent of the parties this petition is converted into appeal and allowed in the aforesaid terms.
